3. RENTER ACKNOWLEDGMENTS & RESPONSIBILITIES

By signing this Agreement, the Renter acknowledges and agrees to the following:

3.1 Inspection & Condition. The Renter has had the opportunity to inspect the Equipment and confirms it is in good working order and free from defects (except as noted in any attached condition report). The Renter accepts the

Equipment "as is".

3.2 Proper Use. The Equipment shall be used only for its intended purpose and in accordance with all manufacturer instructions, safety guidelines, and applicable laws. The Renter shall not modify, alter, or attempt to repair the Equipment.

3.3 Care & Return Condition. The Renter shall return the Equipment in the same condition as received, reasonable wear and tear excepted. The Equipment must be clean, free of debris, and in good working order.

3.4 Damage, Loss & Theft. The Renter assumes full risk of loss, theft, or damage to the Equipment from the time of pickup/delivery until return. The Renter agrees to pay for any repair or replacement costs. A damage report will be provided.

3.5 Late Return. Equipment not returned by the scheduled end date will incur additional charges at the published daily rate (or hourly rate) plus any applicable late fees.

3.6 Prohibited Activities. The Renter shall not: (a) use the Equipment in any illegal manner; (b) sub-rent or loan the Equipment; (c) operate it while impaired; or (d) use it in any manner that could cause injury or property damage beyond normal use.

4. PAYMENT, DEPOSITS & AUTHORIZATIONS

The Renter agrees to pay all amounts due under this Agreement, including the Total Rental Cost, any required deposit authorization, and all additional charges that may apply (damage, late return, cleaning, fuel, etc.).

If a deposit authorization is taken, it will be held via credit card and released (less any deductions) within a reasonable time after satisfactory return of the Equipment.

5. LIABILITY, INDEMNIFICATION & INSURANCE

IMPORTANT — READ CAREFULLY:

To the fullest extent permitted by law, the Renter assumes all risk and liability for any injury, loss, or damage arising from the use, operation, or possession of the Equipment during the rental period.

The Renter agrees to indemnify, defend, and hold harmless {{company_name}}, its owners, employees, and agents from and against any and all claims, damages, losses, costs, and expenses (including reasonable attorneys' fees) arising out of or related to the Renter's use of the Equipment or breach of this Agreement.

The Renter is strongly encouraged to obtain appropriate insurance coverage for the Equipment and any liability arising from its use.

6. DEFAULT, REMEDIES & GOVERNING LAW

Failure by the Renter to comply with any term of this Agreement constitutes a material breach. In the event of breach, the Owner may terminate this Agreement, repossess the Equipment, and pursue all available legal

remedies, including recovery of the Equipment, damages, and collection costs.

This Agreement shall be governed by the laws of the jurisdiction in which the Owner is located, without regard to conflict of law principles.
